Good evening, Suffolk County,

Last month we spoke of how we were not able to do business at the committee meeting. However, this month we were. At the committee meeting it was communicated to us that the September Assembly Meeting will be held, and it will be HYBRID. It was brought to my attention I never brought up the bus last month. I didn't bring it up because there was a possibility that the area meeting would be virtual therefore being a moot point. The bus was cancelled due to not having money in the budget for it.

We discussed how Panel 69 had rotating area assemblies. Each county was responsible for hosting. However, it is A LOT of work, and we would need a budget of 4500 which the area would reimburse.

If anyone wants to submit an agenda item for the 2024 General Service Conference- there will be a sharing session on 8/19/23. Check the delegates page for information.

We voted on an office location for SENY location  $33-01\ 38^{th}$  AVE. It is \$1761 for 755 Square Feet – it will have room for our tech equipment and ARCHIVES. It is however in the basement. I voted for it because we keep losing locations and felt it was important to get a location.

The officers and I had a meeting in July and there were a couple of ideas submitted that I would like to bring to the county. The reason I am bringing these ideas now is to give you an opportunity to think about it. Possibly formulate a motion. We can discuss and vote on in October. Keep in mind that if someone makes a motion and it passes, we will need to amend Group Conscience and look at Bylaws to see if any necessary changes need to be made.

IDEA 1: HAVE AN ALTERNATE TREASURER-Many counties have Asst. Treasurers. Basically, it is a second set of eyes to help audit the Treasures work. Some examples:

- Nassau has a finance committee.
- Certain areas in CT have an Alt treasurer.
- Area 30 Massachusetts Treasurer handles deposit, Alt gets statements.

There are some references in our AA Material: Service Manual (APPENDIX E, PG 29) and in the AA Group Pamphlet (PG 28) that can speak to this. (P71 Northeast Regional Trustee Francis was with us on this conversation- so we owe him ice cream)

IDEA 2 – Have a separate checking account for the Prudent Reserve.
