#### PANEL 1. PARTICIPATION OF ONLINE GROUPS Step 12, Tradition 5, Concept 4

- We started as a virtual meeting and have over 100 members however we have no brick and mortar to attach to so they feel homeless
- Groups limiting service because they are not attached to aphysical location
- Gretchen A48 wrote the proposal they had a virtual district meeting -
  - Offered services on how to do

#### PANEL 2. IS OUR LITERATURE STILL LEVEL TODAY? Step 1, Tradition 1, Concept 2

- · Would rather someone get sober because of inclusivity and meetings are not a history lesson
- Gender language is creating disunity and controversy and not helping AA
- · Some members don't feel like they feel part of because the literature is not inclusive
  - Pronouns create a "bar" from someone coming into the rooms.

#### PANEL 3. MONEY AND SPIRITUALITY. Step 12, Tradition 7, Concept 7

- Are we being spiteful, selfish because we are not getting what we want or agree with withholding \$\$
  and is that also in support of Tradition 5 Hand of AA to always be there?
- Someone suggested AAWS move to OH to save money

#### PANEL 4 THE WORDS OF OUR FOUNDERS. Step 12, Tradition 2, Concept 2

- A woman shared her son died and her husband cheated on her,however she didn't want "Get Sober or die" or every reference in Big Book to "affairs" taken out because these 2 things happened to her
- 44 principles in "To the Wives" and some people feel that chapter is antiquated.

#### PANEL 5 ARE WE COMMUNICATION EFFECTIVELY WITHIN AA. Steps 5/12, Traditions 2/11, Concept 1

- The question was "Do you want a policy with regards to changing the writings?"
- People feeling special comment- made a non binary person not want to be in AA

#### PANEL 6 SAFETY IN AA BELONGING IN AA. Step 12, Traditions 1/3, Concept 9

- People "feeling special" comment- made a non binary person not want to be in AA, not necessary feeling safe but definitely didn't feel welcome (introduce non conf approve "underground" literature at an AA service assembly)
- Safety has evolved local resident stating members transversing property to a beach meeting Going down 45 mph in a 30 mph residential neighborhood on way to meeting ( Safety in AA is just as important in the meeting as it is outside the meeting ) We may be the only face of AA someone sees.
