Minority Opinion: None expressed. **2026 Budget Approved**

**Motion:** (Frank, Mike) **Have SGS spend \$90 per year for a subscription to QuickBooks online.**

Background: We will be able to better integrate a more efficient way of reporting, allows for five users, generates receipts and will facilitate our reporting to the IRS.

Jane: QuickBooks is only good for the people who know how to use it, the people who don't know how to use it are lost. This may limit how many trusted servants are able to use the program after the current rotation as what happened in SENY. Is it the cloud version? Yes.

Tom: QuickBooks is simple as far as accounting goes and is the easiest system beyond Excel for users. The bigger issue is whether people will be willing to stand for Treasurer.

On being prohibitive: The system isn't what is going to be prohibitive.

Christian: The Tech Team had to make modifications and improvements in order for SGS to function that will have to be passed on. The same would be for QuickBooks and the Treasurer.

Security: QuickBooks has great security, backup and redundancy.
